COMINAR ANNOUNCES CLOSING OF \$125 MILLION OF 4.274% SERIES 1 SENIOR UNSECURED DEBENTURES

Quebec City, Québec, June 15, 2012 – Cominar Real Estate Investment Trust ("Cominar") (TSX: CUF.UN) announces today that it has closed its previously announced public offering of \$125 million aggregate principal amount of 4.274% Series 1 senior unsecured debentures due June 15, 2017 (the "Debentures"). The Debentures were sold pursuant to an Agency Agreement with National Bank Financial Inc. and BMO Capital Markets, as co-lead agents, along with a syndicate that also includes Desjardins Securities Inc., CIBC World Markets Inc., Scotia Capital Inc., RBC Dominion Securities Inc., TD Securities Inc., HSBC Securities (Canada) Inc., Canaccord Genuity Corp., Dundee Securities Ltd. and Macquarie Capital Markets Canada Ltd. for total net proceeds to Cominar of approximately \$124.1 million, after deducting the agents' fee and the expenses of the offering. The proceeds from the sale of the Debentures will be used to pay down debt outstanding under current credit facilities of Cominar and for general trust purposes.

The Debentures have not been and will not be registered under the United States Securities Act of 1933 and accordingly will not be offered, sold or delivered, directly or indirectly within the United States, its possessions and other areas subject to its jurisdiction or to, or for the account or for the benefit of a U.S. person, except pursuant to applicable exemptions from the registration requirements.

PROFILE as at June 15, 2012

Cominar is the third largest diversified real estate investment trust in Canada and currently remains the largest commercial property owner in the Province of Québec. Cominar owns a real estate portfolio of 412 high-quality properties, consisting of 82 office, 158 retail and 172 industrial and mixed-use buildings that cover a total area of 30.6 million square feet in Québec, Ontario, the Atlantic Provinces and Western Canada. Cominar's objectives are to pay growing cash distributions to unitholders and to maximize unitholder value by way of proactive management and the expansion of its portfolio.
