# COMINAR ANNOUNCES CLOSING OF \$57.5 MILLION ISSUE OF UNITS

Quebec City, Québec, April 21, 2009 – Cominar Real Estate Investment Trust ("Cominar") (TSX: CUF.UN) announces today that it has closed its previously announced public offering of 4,792,050 units (the "Units"), after full exercise of the underwriters' over-allotment option in respect of the Units. The Units were sold to a syndicate of underwriters led by National Bank Financial Inc. and BMO Nesbitt Burns Inc. for total net proceeds to Cominar of approximately \$54.9 million, after deducting the underwriters' fee and the estimated expenses of the offering. The net proceeds from the sale of the Units will be used to pay down debt outstanding under current credit facilities, which debt was used to finance Cominar's ongoing acquisition and development pipeline.

The Units have not been and will not be registered under the United States Securities Act of 1933 and accordingly will not be offered, sold or delivered, directly or indirectly within the United States, its possessions and other areas subject to its jurisdiction or to, or for the account or for the benefit of a U.S. person, except pursuant to applicable exemptions from the registration requirements.

# Portfolio as at April 21, 2009

Cominar is one of the largest retail property owners and managers in the Province of Québec. Cominar owns a real estate portfolio of 215 high quality properties, consisting of 38 office, 38 retail and 139 industrial and mixed-use buildings that cover a total area of over 18.5 million square feet in the Greater Quebec City, Montreal and Gatineau/Ottawa areas. Cominar's objectives are to deliver growing cash distributions to its unitholders and to maximize unitholder value through proactive management and the growth of its portfolio.
